## **Staff Report**

Subject: Contract with Northwest Hydraulic Consultants (NHC) for the Cook and Butcher Fish Passage and Screen Planning Project (33-23)

### <u>Summary</u>

RCD Staff has selected Northwest Hydraulic Consultants to complete the engineering consulting services for the Cook and Butcher diversion modification. The contract will be not-to-exceed \$174,913 which is within the project budget. Project funding is from CDFW Proposition 1.

## Staff Recommendation

It is recommended that the Board of Directors review and approve the contract with the NHC.

## Consultant Selection Background Information

Project Manager, Ross Perry solicited proposals from qualified engineering firms and received six proposals. District Manager Maureen Teubert, Project Manager Analia Bertucci, and Ross Perry thoroughly reviewed the proposals and scored them based on their qualifications to complete this specific engineering work. NHC's proposal received the highest score. Their initial proposal was not within budget, but the request for proposals did not state that we had to select the lowest bidding firm. Per the review criteria and selection protocol in the proposal solicitation, the highest ranking firm was notified that they had the highest score and were given the opportunity to lower their budget into an acceptable range. NHC re-worked their budget and were able to fit it into the budget constraints for the project without sacrificing any of the necessary elements of the Scope of Work.
